Art, craft, or hobby work must be created by the exhibitor or a family member. The following items will not be accepted:

- manufactured and imported goods
- commercial jewelry
- catalog products
- items made from kits
- consigned goods

We reserve the right to ask exhibitors to remove unsatisfactory items.

Jury

The 2009 jury will be composed of independent, community artists.

Entry Fee

The entry fee is \$80 for a space approximately 10' x 10'.

Application Deadline

March 18, 2009

Sales Tax

According to law, exhibitors must have a sales tax number.

Confirmation

A letter of confirmation, including details and directions, will be sent after March 18. Applicants who are refused will be notified immediately and entry fee returned.

Refund Policy

No refunds will be made after booths are assigned and reservations confirmed (March 25, 2009). The entry fee will not be refunded in the case of misrepresentation of the artist's work.

Parking

After unloading, exhibitors should move vehicles to a designated space in the upper parking lot, leaving more room for customer parking. Selling from vehicles will not be allowed.
